**Re: Mississippi Poultry Exemption Establishment Registration**

Section 75-33-3 (4) states as follows:

“The provisions of this article shall not apply to poultry producers with respect to poultry of their own raising on their own farms on the same basis as now provided in the United States Wholesome Poultry Products Act and regulations thereunder, and such exemptions shall be consistent with said act and regulations. However, the adulteration and misbranding provisions of said act, other than the requirement of the inspection legend, shall apply to articles which are exempt from inspection by said act and regulations.”

§ 75-33-7. Licenses; fees; applications; issuance; posting; agreements with federal authorities as to poultry inspection.

(1) It shall be the duty of every person operating an establishment as defined in Section 75- 33-3, except retail dealers, restaurants or eating places and establishments operating under the U.S. Department of Agriculture system of inspection, to apply to the commissioner for a license to operate such establishment before July 1, 1960, and annually thereafter before July of each succeeding year, and pay to the commissioner at the time said application for registration and license is filed, a fee of ten dollars (\$ 10.00) for each establishment operated, and a like fee of ten dollars (\$ 10.00) for the renewal thereof.

Applications should be completed and mailed along with a check or money order payable to the MDAC, Meat Inspection Division, P. O. Box 1609, Jackson, MS 39215-1609.
