URGENT RECALL ALERT – OPW SWIVELS

March 24, 2017

IMMEDIATE ACTION REQUIRED TO REPLACE HOSE SWIVEL CONNECTORS

AFFECTED OPW PRODUCTS:

- 241 and 241C Swivel Connectors (3/4 inch and 1 inch models)*
- o 36S Swivel Connectors (3/4 inch and 1 inch models)
- * May have been sold as part of a hose kit

<u>Issue</u>: In certain rare cases, the retaining rods used in these models may not perform as expected, resulting in unintended separation at the swivel connections.

<u>Hazard</u>: Unintended separation at the swivel may lead to fuel spillage, posing a chemical or potential fire hazard. While regulations and warnings prohibit the presence of ignition sources at the pump, serious personal injury can result if an ignition source is nevertheless present.

The affected swivels are branded with the model number and a manufacture date on the swivel's end in the format of: MM-YY or MM-DD-YEAR or MM-YEAR. Only swivels with a stamped MFG date of January 2013 through March 2017 are affected. The affected swivels model numbers are:

IMMEDIATE ACTION REQUIRED:

- Inspect your gas pumps and identify any OPW swivel connectors with the affected model numbers and within the affected date range.
- Remove or replace all swivels with the affected model numbers and within the affected date range.
- If the swivel was installed as part of a hose kit, only the swivel needs to be replaced, not the entire hose kit.
- Register for the recall using the https://OpwSwivelRecall.expertinquiry.com
 website or by calling 1-866-562-5931 between 9am and 5pm EST Monday through Friday. You must provide contact information and certain information to identify the affected swivels to be replaced.
- OPW will directly ship new, alternative swivels to replace your recalled swivels.
- Tag and dispose of the recalled swivels per the instructions provided with your new swivels.
- REMOVE OR REPLACE AND DO NOT REUSE RECALLED SWIVELS. THERE
 IS A RISK OF FIRE, SERIOUS PERSONAL INJURY, AND DEATH.
