## **BASIC PRODUCE SAFETY RULE EXEMPTION RENEWAL**

## **Requirements for Qualified Exemption:**

Both of the following requirements must be met.

A. During the previous 3-year period, annual food sales are less than \$500,000 adjusted for inflation, and the amount of sales sold to qualified end-users exceeded the amount sold to all other buyers.

AND

B. You sell more than 50% of your annual food sales to qualified end-users (consumer of the food and/or a restaurant or retail food establishment) located in Mississippi or within the same Indian Reservation or within 275 miles of your farm.
