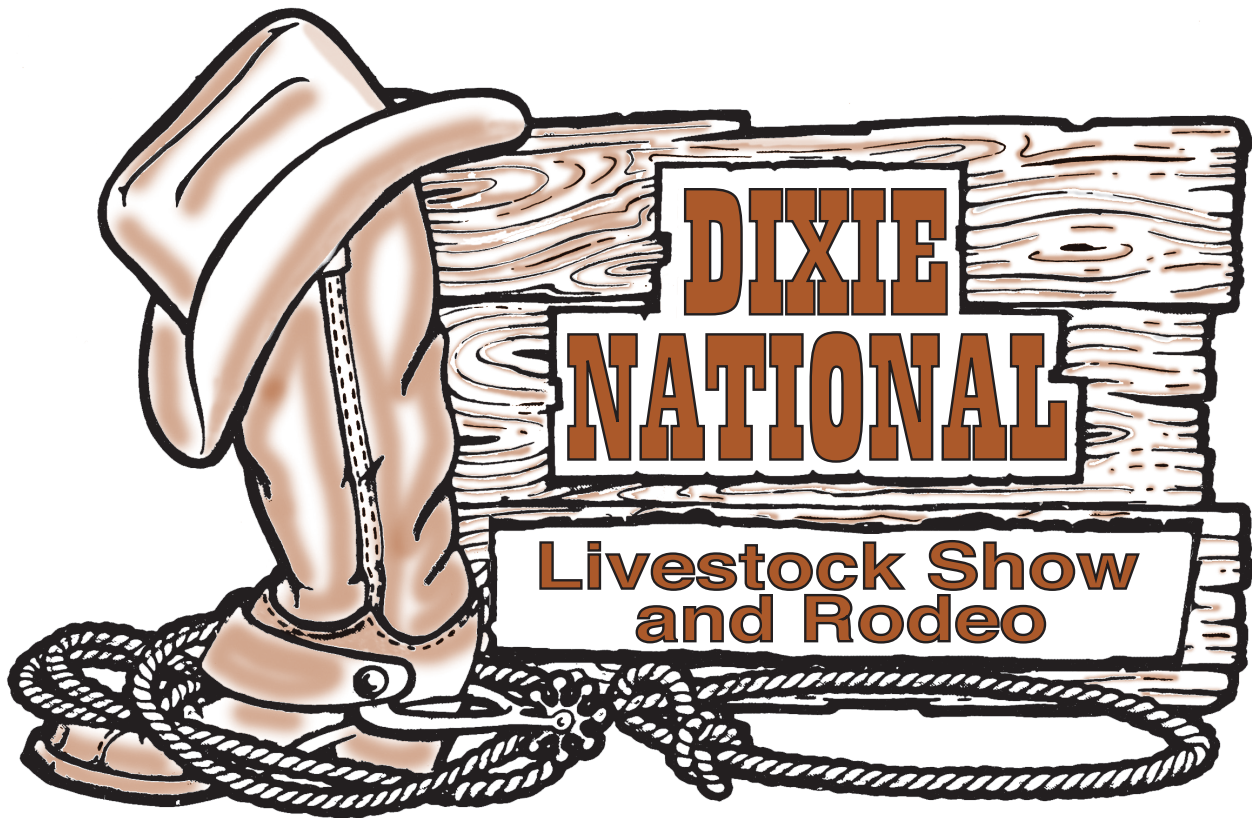

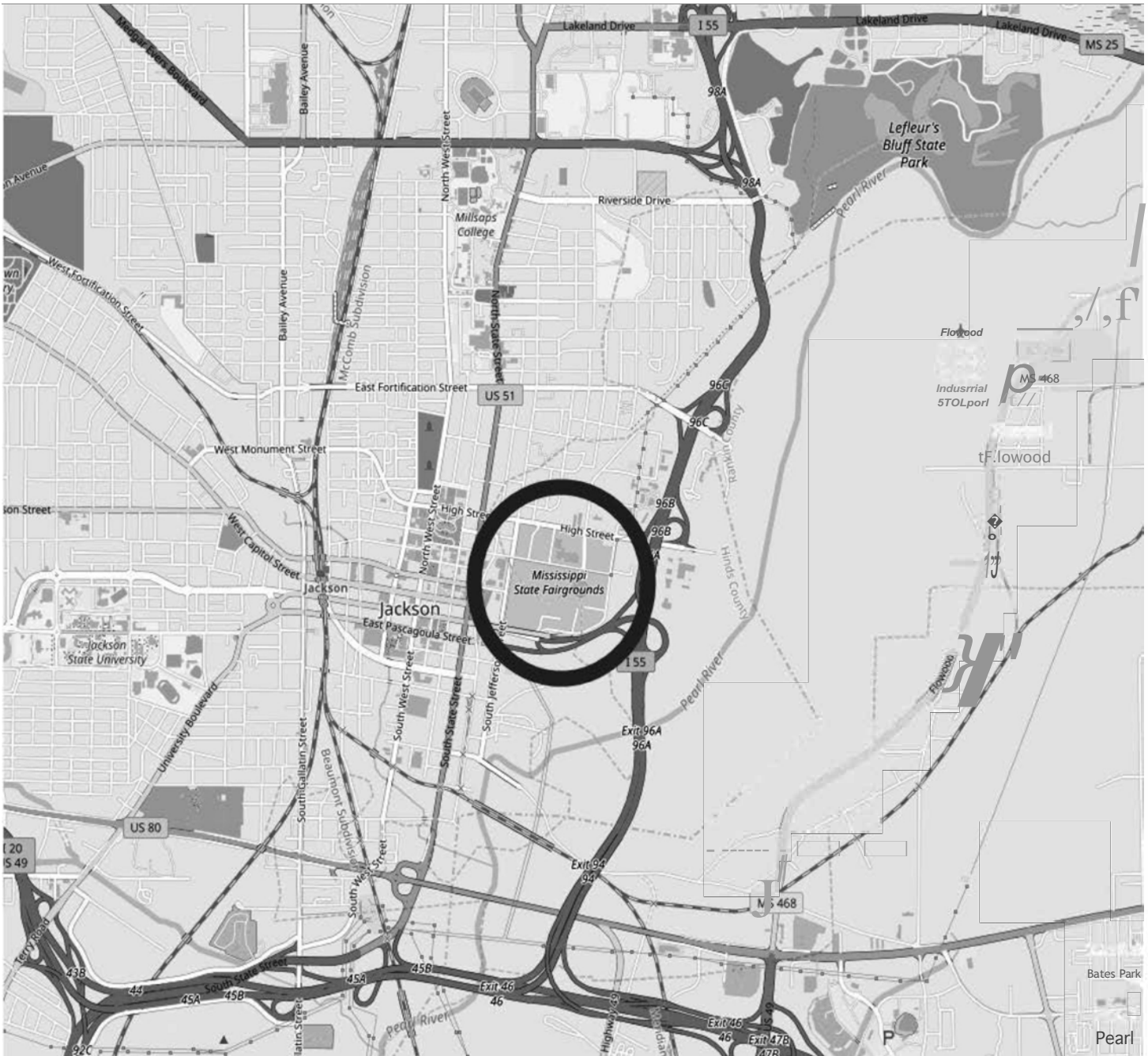

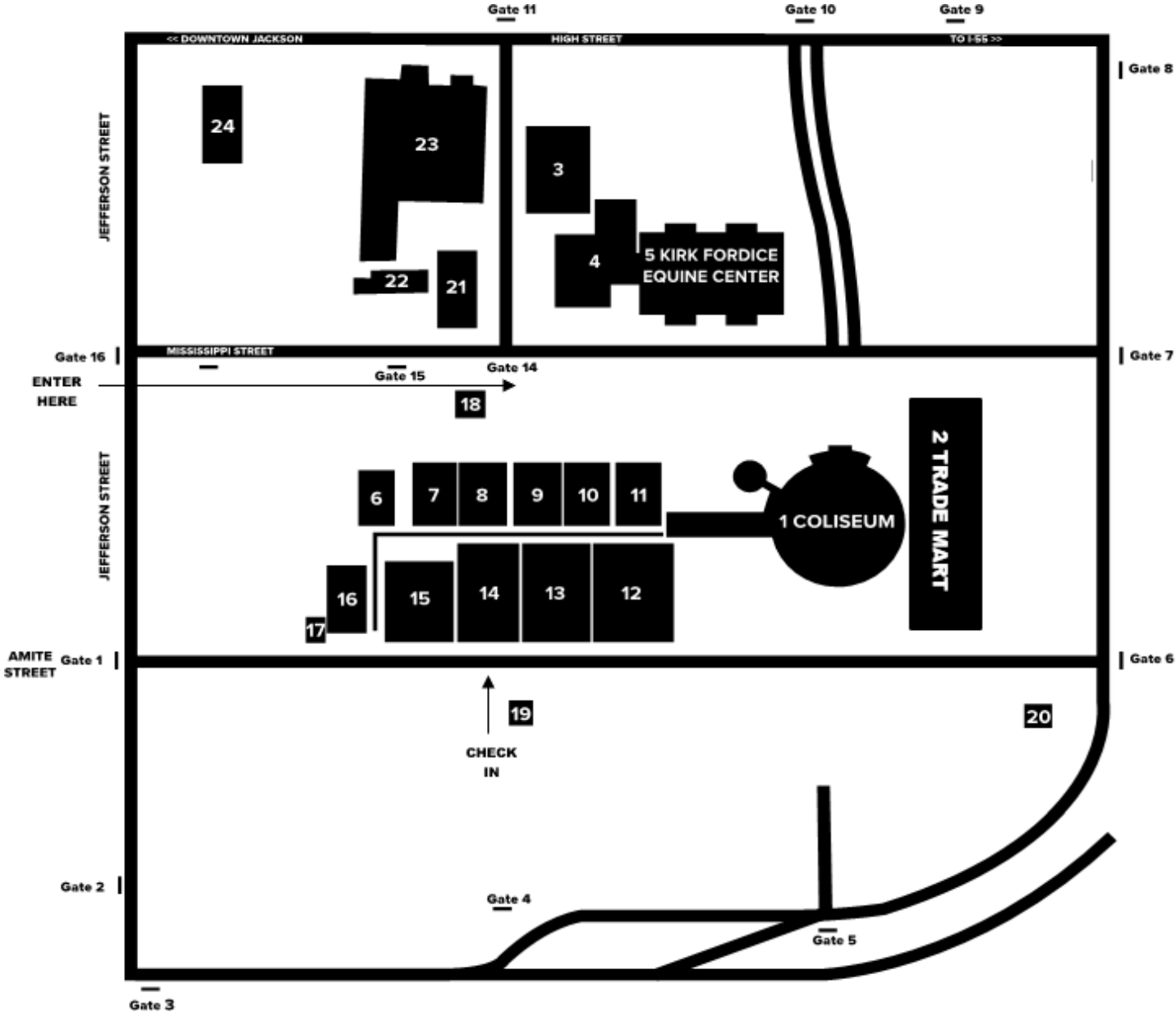


# LOCATION OF DIXIE NATIONAL LIVESTOCK SHOW MISSISSIPPI STATE FAIRGROUNDS

# GENERAL INFORMATION

## ADMINISTRATIVE OFFICE

The Fairgrounds administrative offices are in the North Side of the Coliseum. The Superintendents of the various departments may be contacted in the building in which their exhibits are displayed.

## EXPRESS

Express shipment must be prepaid if addressed to the Mississippi State Fairgrounds and will be delivered to any location designated.

## MAIL

Mail addressed to anyone in care of the Dixie National will be placed in the Manager's office in the Mississippi Coliseum.

## RESTROOMS

Restrooms are located on the Fairgrounds in connection with exhibit buildings and along the Midway.

## AUTOMOBILE PARKING

Parking is available inside and outside the Fairgrounds. Security officers will be on the Fairgrounds to prevent theft. However, the Dixie National will assume no responsibility for any loss or damage that may occur.

## HAY, WHEAT STRAW & SHAVINGS

Exhibitors of livestock may purchase hay, wheat straw and shavings from the shaving office located in Barn 3.

## ADVERTISING

No person shall be allowed to distribute any printed advertising matter on the Fairgrounds or in the buildings, except for an exhibitor distributing their own business information from their assigned exhibit space.

## \*\*\*\*FIRE SAFETY\*\*\*\*

Officials of the State Fire Marshal's Office have worked very closely with the staff of the MS Fair Commission to help ensure your safety and enjoyment while at the Mississippi State Fairgrounds.

For your safety and the safety of others, the livestock exhibitors and visitors will be required to use only heating and cooking devices that are described as follows:

- **All heating devices used in livestock buildings must be UL approved and equipped with an oxygen shutoff sensor (ODS) automatic shutoff.**
- **No heating or cooking fuels may be stored in barns. Any cooking devices left unattended will be removed from barns. No charcoal grills or smokestack type heaters that use any type of liquid fuel will be allowed in the barns. All cooking and heating devices must be kept away from hay or other flammable materials.**
- **All electrical cords must be grounded.**

## GENERAL RULES AND REGULATIONS

NOTICE: All exhibitors are cautioned to read carefully the following rules and regulations. They will be enforced strictly with no exceptions.

1. The Dixie National Livestock Show reserves to its Staff and Management the final absolute right to interpret these rules and regulations, and to arbitrarily settle and determine all matters, questions and differences in regard thereto, or otherwise arising out of, connected with, or incident to the Livestock Show.
2. The Management reserves the right to amend or add to these rules as it, in its judgment, may deem advisable.
3. Any person who violates any of the general rules or special rules, as published in this Premium List, will forfeit all privileges and premiums won.
4. Every exhibit must be in place and properly installed and remain intact under the rules and regulations of each department, unless other provisions have been approved.
5. All livestock of every breed, cross breed or variety entered for competition or display, or any other purpose or being anywhere on the Fairgrounds, shall be subject to the control of the Show Management, but in no case shall the Dixie National be held responsible for any loss, damage or injury of any character to any such livestock while such entries are on the Fairgrounds or at any time or place. Livestock owners and exhibitors, or others interested in such livestock, desiring protection against loss or injury from any other cause must make arrangements for such protection.
6. No claim for injury to any person or to any livestock shall ever be asserted, no suits instituted or maintained against the Dixie National, or its officers or agents, by or on behalf of any person, firms or corporations, or other agents, representatives, servants or employees, having license or privilege to exhibit on the Fairgrounds or to occupy any space on the Fairgrounds.
7. LIABILITIES: All exhibits will be under the control and direction of the Management. However, the Dixie National will in no case be responsible for any loss, injury or damage that may occur. Each exhibitor will be solely responsible for any consequential or other loss, injury or damage done to, occasioned by, or arising from, any animal or article exhibited by him and for its description, as given in the Premium List. He shall indemnify the Dixie National against all legal or other proceedings in regards thereto, as well as the exhibitor or any of the animals exhibited by him, or arising out of, or in any way connected with such exhibition or any of the animals so exhibited.
8. The Management reserves the right to remove from the grounds any exhibit animal that may be falsely entered or may be deemed unsuitable or objectionable, without assigning a reason, and if necessary, to return any money already paid for space, or stall, which shall exonerate them from any claim whatsoever on the part of the exhibitor or purchaser.
9. All owners of livestock, or other property or others having same in charge shall care for, guard, protect and preserve the same, as the Dixie National does not undertake to do so, and it shall not be held responsible for any loss or damage to said property or livestock.
10. SALES - Sales held during the Dixie National must be sponsored by the state, regional or national association or sponsoring agency of a breed participating in the Dixie National. Entry fee for sale or display cattle is \$30.00/head.
11. ALL ELECTRICAL CORDS MUST BE GROUNDED.
12. A designated tie-out area is located in the northwest corner of the fairgrounds.
13. No 4-Wheelers or scooters allowed on the Mississippi State Fairgrounds. Golf carts are allowed only if driver is 18 years old or older.
14. No dogs are allowed in any barn or building on the show grounds, except for certified service dogs to aid the handicapped.

## ENTRIES

All rules and regulations concerning the individual entry, or entries, of livestock of any breed, cross-breed or variety specified in this Premium List will be found under the respective heading for such breed, cross-breed or variety.

1. All livestock entering the Dixie National showground must be accompanied by an official health certificate and must be apparently free of any contagious, infectious or communicable disease. In addition, adherence to any special rules required by the MS Board of Animal Health for that particular species of livestock is required.
2. Any animal not meeting the requirements of the Premium List, as to pedigree and registration, will be barred from competition.
3. Each entry in the Dixie National Livestock Show will be assigned a number in the Official Livestock Catalog. This number will identify animals in the show and will correspond with an Official Livestock Catalog number, which must be properly displayed when the entries are being judged.
4. Exhibits that have been erroneously entered may, at the discretion of the Management, be transferred to their proper classes prior to judging.
5. STALLS: No stalls or pens will be reserved without the required fee. Stall space and pens will be assigned in order of receipt of entries. Because of the critical shortage of space, no stalls will be rented or reserved for equipment boxes, advertising or feed.
6. ENTRIES:
  - a. All entries must be made online at [www.dixienational.org](http://www.dixienational.org). All fees must accompany the online entry. Deadline to register is January 24, 2025. Due to the large number of entries, no late entries will be excepted.
  - b. Premiums will be paid only to the exhibitor in whose name the entry is made. Social Security Number or Federal Tax I.D. number must be provided to receive premium payout.
7. Sale cattle must be halter broken and tied in the cattle barn.
8. TIME OF ENTRIES: Entry deadline will be January 24, 2025. Exhibitors are urged to make entries as soon as possible.
9. FEES:

10. FEED & BEDDING: Each exhibitor will be responsible for providing his own feed and bedding.
11. ARRIVAL TIME:

**CATTLE** to arrive between 8:00 a.m. and 5:00 p.m., Friday, February 7<sup>th</sup>, between 12:00 p.m and 5:00 p.m., Thursday, February 13<sup>th</sup>, between 8:00 a.m. and 12:00 p.m., Friday, February 14<sup>th</sup>. Cattle arriving earlier will not be stalled but may be tied out.

**SWINE** to arrive between 8:00 a.m. and 12:00 p.m., Saturday, February 8<sup>th</sup>.
12. STALL ASSIGNMENTS will be made between 8:00 a.m. and 5:00 p.m., Friday, February 7<sup>th</sup>, between 12:00 p.m. and 5:00 p.m., Thursday, February 13<sup>th</sup>, between 8:00 a.m. and 12:00 p.m., Friday, February 14<sup>th</sup>. Cattle arriving earlier will not be stalled but may be tied out.
13. RELEASE TIME: All cattle shown on Saturday, February 8<sup>th</sup>, and Sunday, February 9<sup>th</sup>, will be released Sunday, February 9<sup>th</sup> at 5:00 p.m. All cattle shown on Monday, February 10<sup>th</sup> will be released at the conclusion of the show. All cattle shown on Friday, February 14<sup>th</sup> and Saturday, February 15<sup>th</sup> will be released Saturday, February 15<sup>th</sup>. All cattle shown on Sunday, February 16<sup>th</sup> will be released after the show.
14. TIE OUT TIME: 5:00 p.m.

15. If it be ascertained that any exhibitor has made or caused to be made any false statement in regard to any animal or equipment exhibited, or if any exhibitor shall attempt to interfere with the judges in the performance of their duties, such exhibitor shall be excluded from competition or exhibition in the Dixie National Livestock Show; and any premium or premiums previously awarded to such exhibitor shall be forfeited.
16. Animals entered in the Adult Division must be owned by the exhibitor thirty days prior to the opening date of the show. All exhibitors of breeding stock must be prepared to show certificates of registry in standard associations and identification of animals with such certificates when required by the superintendent. If entry is not made, as required by the rules, premium will not be paid although awarded by the judge.
17. A single animal may be exhibited as one of a pair, a herd, or a group if classes are offered. Animals shown in group classes must be shown in single classes and must meet age requirements for those shown in classes for single animals.
18. No substitution of any animal will be allowed after the entries are officially closed, unless approval has been secured from the Show Manager. Any exhibitor having an animal which will not be shown must notify the Superintendent or the Livestock Show office before the class is called.
19. No animal may be entered in more than one show.
20. By making entry in the Dixie National Open Cattle Shows, exhibitors give their consent to permit the use of cattle in the Dixie National Collegiate Beef Judging Contest.

## **PHOTOGRAPHS**

Photographs of Champion and Grand Champion livestock will be taken by the Official Photographer of the Dixie National. All owners, exhibitors and herdsman handling such animals are required to cooperate with the Official Photographer in arranging for taking such pictures.

## **PROTESTS AND APPEALS**

1. All protests must be made in writing and accompanied by a deposit of \$25.00, which deposit will be forfeited if protest is not sustained. The protest must be filed with the Management within five hours after the award was made, considering that award was made when ribbon or premium card is placed. Appeals must contain at least one specific charge stating at length the facts or the rule violated, and naming witnesses and address who can substantiate the charge.
2. No complaint or appeal based upon the statement that the judge or judges are incompetent or have overlooked an animal or article will be considered by the Management.
3. The right of an exhibitor to appeal from the decisions of a judge to the Management will lie only when it is charged that the award has been made in violation of the rules governing the exhibit; or when it is charged that the decision of the judges had been influenced or interfered with by another.

## **PREMIUMS AND AWARDS**

1. The judge will award premiums only on articles regularly mentioned in the schedule of premiums. The decision of the judge shall be final, and no appeal will be considered. Examinations for premium awards in all departments will begin at the time specified in the schedule of events and will continue until all classes have been passed upon.
2. The judges in all departments will be appointed by the Rules and Regulations Committee. No one will be allowed to act as judge in the class or ring in which he exhibits.
3. All premiums awarded under the rules and regulations of this premium list will be paid according to the rules.
4. The Management reserves the right to return entries and cancel any class in which, in its judgment, the number of entries is insufficient to insure adequate competition. Where there are fewer entries in a class than the number of premiums offered, the judge may, at his discretion, award prizes of such grade as the animal/ animals deserve(s), but in any event, regardless of the number of entries listed in the catalog, where the

animals of only one exhibitor or his immediate family are shown, the judge will award only one prize, which may be of the grade to which the judge feels that the exhibit is entitled, and need not necessarily be a first or second prize.

5. Errors in premiums statement will not be corrected after May 31, 2025.
6. Premium checks must be cashed within sixty days of issuance, or they become void.
7. Only two premiums will be paid to any one exhibitor in one class.
8. The Dixie National will not pay premiums on championship classes.
9. The following colors will be used in designation awards:

Reserve Grand Champion	White
First	Blue
Second	Red
Third	White

# MISSISSIPPI BOARD OF ANIMAL HEALTH

## Health Requirements Governing Admission of Livestock for Dixie National Livestock Show Jackson, Mississippi

All livestock entering the Mississippi State Fairgrounds shall be accompanied by an Official Health Certificate and be apparently free of any contagious, infectious or communicable disease and individually identified with Official USDA Identification.

All out-of-state animals must meet the Entry Requirements for the State of Mississippi. It is important to check these regulations prior to entry into Mississippi as the information below may have been changed. These regulations may be found at: <https://www.mbah.ms.gov/regulations/chapter-12/>

### SECTION I - CATTLE

All cattle except nursing calves, must be individually identified (with Official USDA ID) on the Health Certificate.

#### A. Brucellosis

Calfood Vaccination for females is not required.

#### B. Tuberculosis:

All beef cattle of all ages shall:

- Originate from an Accredited Free State or;
- Originate from an Accredited Tuberculosis Free Herd. Certificate number of the herd and date certified shall be entered on the Health Certificate.

Or

- Have been negative to a test made within sixty (60) days prior to the date of shipment, and in addition from a non-quarantine herd in a modified accredited tuberculosis free area.
- All Dairy Cattle must be from an Accredited Free Herd or have negative TB Test within 30 days of entry.

#### C. Trichomoniasis

- Bulls under 18 months of age must have a "Virgin Bull Statement" or a negative Trich Test.
- Bulls 18 months of age or older must have a negative Trich Test.
- Bulls for exhibition only may enter without a Trich Test, but if sold while in the state must have a negative Trich Test.

### SECTION II - HORSES

**All horses shall be accompanied by:**

1. Official interstate health certificate stating horse is apparently free of any contagious, infectious, or communicable disease with Lab date, number and test results recorded.
2. Original laboratory chart of negative Equine Infections Anemia (Coggins Test) made within twelve (12) months, with proper animal identification listed thereon. Photocopies **WILL NOT** be accepted (unless they have the signature of the submitting veterinarian).

### SECTION III - SWINE

General: All swine for breeding purposes must be accompanied by an official health certificate and a permit prior to movement obtained with the number of the permit shown on the certificate. All swine must be individually identified (Official USDA Identification) on the health certificate and must originate from herds that have not had an infectious or communicable disease within the past 30 days prior to movement, and this statement written on the health certificate: **“To the best of my knowledge, swine represented on this certificate have not originated from a premise known to be affected by an infectious or contagious disease within the last 30 days.”**

### SECTION IV - DUTIES OF CARRIERS

- A. Owners and operators of private and common carriers, trucks, and other conveyances are forbidden to move any livestock into or through this state except in compliance with provisions set forth in these regulations.
- B. All trucks and other conveyances used for the transportation of livestock and poultry shall be maintained in a sanitary condition.
- C. Owners and operators of trucks and other conveyances shall have such vehicles thoroughly cleaned and disinfected under official supervision, before their use for the transportation of livestock into the State of Mississippi.  
All livestock entering Mississippi must meet Title 9, Sub-chapter C, Interstate Transportation of Animals and Poultry, and Part 83 of the Federal Screwworm Regulation, as adopted April 20, 1966.

## **OPEN CLASS PARTICIPATION STATEMENT AMERICAN ANGUS ASSOCIATION**

The American Angus Association, 3201 Frederick Avenue, St. Joseph, Missouri, will participate in premiums offered for open class Angus breeding cattle classes according to the premium schedule based on the number of head shown. The premium assistance provided by the American Angus Association for participation in this show is in addition to the premiums offered by the show itself. Premium assistance should not be used to offset show expenses and shall be included in the premium payments distributed by the show to the exhibitors.

A minimum of 50 head must be shown in the open class division to receive American Angus Association premium participation for the following year.

Premiums from the association are paid only to registered Angus cattle and only if the registration number is a part of the show report provided to the Association. Therefore, all cattle should be registered at the time of entry to make certain they receive the Association's portion of premiums. The Association does not pay on championship or any group classes (i.e. get-of-sire, junior get-of-sire, or breeder six-head).

Exhibitors must have the original registration certificate issued by the American Angus Association available for inspection at the show for each animal or another current proof of ownership issued by the American Angus Association pedigree look-up. Any animal, upon check-in, which does not have a legible permanent identification mark (ear tattoo marks, freeze-branded marks, or hot-branded marks) corresponding to the permanent identification mark on the registration certificate, is ineligible to show. Once disqualified due to an incorrect or illegible permanent identification mark, animals cannot be re-identified (tattooed/branded) and rechecked at the show.

Any female shown with calf at side: The calf must be the cow's most recent natural calf, and the calf must be registered by show day and have proof of registration at check in.

Only one person at a time shall lead animals into the show ring.

*Exhibitors who participate in shows that accept premium monies contributed by the American Angus Association are subject to the Association Rules as found in the Breeders Reference Guide of the Association. These rules are found in Part 2; Association Rules. The rules relating directly with the exhibition of Angus cattle are Part 2; Association Rules; Rule 800 Series; including Rule 800 - 810. These rules can be found at [www.angus.org](http://www.angus.org).*

Altering the conformation and/or appearance of an animal for exhibition is prohibited. This includes the covering of white skin, false tail heads (or use of any false hair), with the exception of false tail switches. The use of graphite, powder, hemp or other similar substances externally are also prohibited. Other prohibited products include those used internally such as steroids, illegal or unlicensed pharmaceuticals or artificial filling. Any animal found to be in violation will be barred from showing.

At any show for which the American Angus Association appropriates funds toward the payment of premiums, no exhibitors, individuals assisting exhibitors or member owners at such show shall be allowed to use any coloring agents on any animal exhibited. The Association may adopt and implement various tests designed to monitor this prohibition, including but not limited to a "white towel" or "white glove" test. No aerosol cans or other pressurized containers will be allowed in designated line up areas.

All animals exhibited are subject to DNA marker or blood type tests to verify accuracy of parentage as covered under the Association Rules and for other testing as required by the individual show.

Authorized representatives of the Association have the authority to enforce the rules set forth herein as well as in the Association Rules, including the barring of a registered animal from a livestock show at which it is to be shown, if there are reasonable grounds to believe a violation has occurred.

5. Only one (1) person per animal is permitted in the show arena during the exhibition of individual classes, with exceptions made by one of the following: a.) A physical or mental disability that prevents the proper handling of the animal without assistance or, b.) a handler has a physical injury (sprained ankle, broken arm, etc.) that requires assistance. Any request for an assistant shall be presented to an attending BPG Director or Officer before the beginning of the show for a ruling. In the event that an assistant is required and approved, the assistant shall provide the least amount of interference as possible for the handler to properly display the animal and shall not interfere with any other entrant or otherwise block the path or view of the Judge.
6. All animal tattoos may be checked for legibility and must match the registration papers for that animal. Animals with illegible tattoos or incorrect papers will not be allowed to show.
7. Heifers exhibited at 24 months of age or older must be accompanied by a certificate of pregnancy or be nursing their natural calf-at side. If calf is over 6 months old, cow must be palpated safe in calf and so stated on health papers.
8. All bulls 12 months and older must be led with a nose lead at all times.
9. Animals entered in group classes, must have been shown in an individual class.
10. All BBU registered animals must be shown with their hair coats lying downward and flat against their entire body. Hair trimming is permissible and must be done in those few areas such as the neck and portions of the topline of the animal which may not lay flat against the body. Hair may not be trained upwards or forwards and/or pulled upwards or forwards on any part of the animal's body. No animals may have any foreign object(s) attached to it in any manner or have its natural color altered in a manner so as to change the conformation or appearance. An exhibitor who fails to abide by this rule will be dismissed from the arena and/or forfeit premiums, awards and points from the show.
11. Each animal must be presented in the show ring in its natural conformation and structure without alteration or modification. Alteration or modification shall be defined to include any surgical, chemical, electrical, or other appearance change for cosmetic purposes (such as silicon injections or other injections for cosmetic purposes), save only branding, tattooing, foot trimming or dehorning.
12. All bulls 20 months of age or older that are exhibited must have passed a fertility examination given by a licensed veterinarian to be eligible to show and the results must be presented at check in. Once a bull has a positive exam, retesting is not required.
13. Determinations regarding classes and the splitting of classes shall be made in the sole discretion of the show official or coordinator and are not subject to review or protest.
14. Any and all protests must be written and be filed with a BPG officer or Director no later than 1 hour after the conclusion of the show, accompanied by a \$150 non refundable protest fee.
15. For and in consideration of the opportunity to participate in a BPG approved show, each exhibitor hereby releases Beefmaster Promotion Group and their respective officials, sponsors, agents, officers, directors, employees and representatives, from any and all claims, liabilities, suits and judgments, arising from or connected with the administration or use of any animal test, rule enforcement and the resulting decision or action based there on.
16. The BPG Code of Conduct will be enforced.

## BEEFMASTER

### CODE OF CONDUCT

1. Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agriculture
2. All persons, exhibitors, owners, trainers, fitters, parents, show officials, etc., are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Obscene or discriminatory language or insubordination of any kind will NOT be tolerated. Parents, guardians, exhibitors, owners, trainers, fitters, family members who violate the code of conduct will forfeit awards, premiums, etc. and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs, livestock shows and the Beefmaster Promotion Group (BPG). Exhibitors who violate this code of conduct demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States.
3. All exhibitors shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
4. Member exhibitor and member owners, as well as their family members, representatives and employees, shall act in a sportsmanlike and professional manner while attending any BPG show, sale or event. Judges, show officials, fellow exhibitors and all event attendees shall be treated with courtesy and respect. Exhibitors or owners shall not engage in or direct any abusive, threatening or obscene conduct toward judges, show officials, other exhibitors or any BPG event attendees.

The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair, livestock show or Beefmaster Promotion Group may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including any publications of the breed association and the Beefmaster Promotion Group.
7. The act of entering of an animal in a fair, livestock show or BPG sponsored event is the giving of verification by the parent, guardian, owner, exhibitor, trainer, fitter, family member that he or she has read these rules and understands the consequences of and penalties provided for actions prohibited by such. It is further a consent that any action which contravenes these rules and is also in violation of federal or state regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.
8. Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
9. Authorized representatives of the BPG Association have the authority to enforce the rules set forth herein,
10. All BPG members will abide by the show rules adopted and posted on [beefmasterpromotiongroup.com](http://beefmasterpromotiongroup.com), regardless of show premium book. These rules supersede the Show Rules published by an Association-approved livestock show, to the extent that there is a conflict.
11. For and in consideration of the opportunity to participate in any BPG approved show, each exhibitor, owner, family member hereby releases BPG its officers, directors and representatives from negligence, any and all claims, suits and judgments, either past, present or future, arising from or connected with the administration of use of such test or examination and the resulting decision therefrom.

A minimum of 20 Braford animals as well as 20 Braford F-1 females must be shown at each of the 7/6 F-1 shows for the year end awards to be presented for 2024-2025 in their respective divisions.
3. An animal found to have evidence of incisions, surgical or otherwise, in the following areas: testicles, sheath, navel, or dewlap will be disqualified from showing.
4. Animals unethically fitted to alter the conformation or appearance of the animal will be disqualified. Cattle displaying tail ties and hairnets used on the tail will be allowed.
5. Calves shown at the side of Braford cows must be registered purebred Brafords. If bred, F1s must be bred to Brahman or Hereford bulls or bulls that will produce purebred Brafords. If shown with a calf at side, the calves must be registered with the UBB and must be purebred Brafords; 3/4 Brahman and 1/4 Hereford; or a 1/4 Brahman and 3/4 Hereford. Bred F1 females shown must have available the registration number of the service sire.
6. All Braford entries are subject to the provision of a rule of the United Braford Breeders entitled "Inspection of Exhibits."
  - a. The association and its representatives have the authority to require such tests as they deem necessary to verify the accuracy of the classification and pedigree of exhibited animals. "Said authority shall extend to and cover the enforcement of all Show rules as adopted by the UBB."
  - b. Each exhibitor shall submit his registered Braford cattle to such tests and examinations as requested and/ or required by the association, its authorized representatives, or the authorized representatives of the relevant show. These tests and examinations shall include but are not limited to any weighing, measuring, or ultrasound evaluation of the animals as required by the UBB's Show Committee.
  - c. For and in consideration of the opportunity to participate in any Braford function, exhibitor hereby releases the Association, its officers, directors, and representatives from negligence, any and all claims, suits and judgments past, present or future, arising from or connected with the administration or use of such test or examination and the resulting decisions therefrom.
7. All protests must be made in writing and be accompanied by a deposit of \$200.00 which will be forfeited if protest is not sustained. Such protests must state plainly the cause of complaint or appeal and must be delivered to the UBB Show Committee immediately after occasion for each protest. Depending on the basis of the protest, a decision may be withheld until complete investigation is completed.
8. Only UBB registered cattle are allowed to compete in UBB sanctioned shows (listed above, no. 3). Golden certificated numbers will not be accepted.

### ABBA OFFICIAL SHOW CLASS SPECIAL CONDITIONS

- A. All Animals exhibited must be registered with the American Brahman Breeders Association (“ABBA”) and be appropriately fire branded as provided by ABBA requirements for registration in the ABBA Official Brahman Herdbook.
- B. All Animals exhibited are subject to the ABBA Color Classification Rules as established from time to time. A copy of the most current ABBA Color Classification Rules may be obtained from the ABBA.
- C. All animals exhibited are subject to the ABBA DNA Verification Rules as established from time to time. A copy of the most current ABBA DNA Verification Rules may be obtained from the ABBA.
- D. All Females exhibited in the **Senior Division** must either [1] be accompanied by a certificate of pregnancy issued by a licensed veterinarian (within 90 days prior to the date of the Show) certifying the Animal is pregnant and such certificate shall be made available for inspection and verification upon request, [2] be in a lactating stage and have her natural, nursing calf at side, which Calf has not exceeded 240 days old as of the date of the Show, or [3] have weaned her natural calf which Calf is registered in the ABBA Official Brahman Herdbook and the Calf’s registration certificate is available for inspection and verification upon request.
- E. All Females exhibited in the **Aged Senior Division\*** must either [1] be in a lactating stage and have her natural, nursing calf at side which Calf has not exceeded 240 days old as of the date of the Show, or [2] have weaned her natural calf which Calf is registered in the ABBA Official Brahman Herdbook and the Calf’s registration certificate is available for inspection and verification upon request. ***\*FOR THE SPRING 2024 SHOW SEASON ONLY, FEMALES EXHIBITED IN CLASS 34 LATE AGED SENIOR COWS SHALL BE ALLOWED TO BE EXHIBITED WITHOUT A NATURAL, NURSING CALF AT SIDE PROVIDED THE FEMALE MEETS THE PREGNANCY STATUS REQUIREMENTS OF THE SENIOR DIVISION OF FEMALES.***
- F. All Bulls must be exhibited with a permanent or temporary nose ring with an appropriate lead attached.
- G. All Bulls exhibited in the **Senior and Aged Senior Divisions** must be accompanied by a valid, satisfactory Breeding Soundness Exam (BSE) certification issued by a licensed veterinarian (within one year prior to the date of the Show) and such certification shall be made available for inspection and verification upon request.
- H. All Animals in the **Calf and Junior Yearling Divisions** which have been previously disqualified from being exhibited at an ABBA Approved Show based on not meeting Weights and Measures Parameters may not be exhibited at another ABBA Approved Show until such time as [1] the Animal re-qualifies by meeting Weights and Measures Parameters at a subsequent ABBA Approved Show where weights and measures are taken, or [2] the Animal is no longer being exhibited in the Calf or Junior Yearling Divisions at ABBA Approved Shows.

- I. All **Group Classes** will be exhibited at the beginning of the ABBA Approved Show prior to any individual classes being exhibited in such Show. All individual Animals exhibited in Group Classes must be presented by an individual Showman for each participating Animal for the Group to be placed by the Judge(s).
- J. All Animals exhibited in the Get of Sire, Natural Produce of Dam and Embryo Produce of Dam Group Classes at an ABBA Approved Show must be exhibited under the registered color of the represented Sire or Dam; NOT the color of the progeny comprising the Group. The Breeders Genetic Group and Breeder's Herd shall be exhibited under the registered color of the individual Animals (which all must be registered as the same color) comprising the Group.
- K. All Classes which exceed more than fifteen (15) Animals MAY be broken into smaller Classes each no larger than 15 Animals, at the sole discretion of Show Management, by dividing the Classes as evenly as possible without splitting Animals with the same birth date. Additional Classes resulting from splitting Classes shall be treated as new individual Classes (and not as heats of a single Class) for purposes of class placings, competition within Divisions, and ABBA Register of Renown Points awarded.

No ownership requirement for the participating individual Animals in the Group. No single Exhibitor shall be permitted to show more than one entry per Dam. All entries in this Class must be placed by the Judge(s). There will be named a Champion and Reserve Champion of this Group Class.
- G3. *GET OF SIRE* - Four (4) Animals all by the same Sire from at least two different Dams, both sexes must be represented. Each Animal in the Group must also be exhibited in the appropriate individual Class for such Animal. No ownership requirement for the participating individual Animals in the Group. No single Exhibitor shall be permitted to show more than one entry per Sire. All entries in this Class must be placed by the Judge(s). There will be named a Champion and Reserve Champion of this Group Class.
- G4. *BREEDER'S GENETIC GROUP* - Three (3) genetically similar Animals all by the same Sire and same Dam, either or both sexes may be represented. All individual Animals comprising this Group shall be registered with the ABBA as the same color and shall be exhibited based on the color of the individual Animals comprising the Group as registered with the ABBA. Each Animal in the Group must also be exhibited in the appropriate individual Class for such Animal. No ownership requirement for the participating individual Animals in the Group. No single Exhibitor shall be permitted to show more than one entry per Sire and Dam mating combination. All entries in this Class must be placed by the Judges(s). ## Eligibility

1. The owner(s) of record on all animals entered in an IBBA National or Regional point show must be an active member(s) of the IBBA in good standing.
2. Animals must be registered Brangus, Red Brangus, UltraBlack, or UltraRed with the International Brangus Breeders Association (IBBA) to be eligible to compete in an IBBA-sponsored show. Animals recorded in the IBBA Appendix registry are ineligible to show.
3. UltraBlacks and UltraReds must show separately from Brangus and Red Brangus, with the exception of calves shown at the side of their dams in both the Female and Cow Calf show. The registration prefix of the dam determines the classification of the pair.
4. All calves exhibited at the side of the female must be registered with the IBBA and meet all rules required for show eligibility and inspections of exhibits (refer to Rule 9.a.). The registration prefix of the dam determines the classification of the pair.
5. Animals eligible to be shown in group classes must be entered and shown in respective individual classes. Cows exhibited in the cow/calf classes are not eligible for the group classes.

## Animal Identification

6. The registration certificate (or photocopy) for each entry must be available for presentation to the Superintendent or show manager at the time entries are verified prior to judging. Digital images and herd book data sheets will not be accepted.
7. Once an animal's identification has been verified by visual inspection of a brand or ear tattoo, its registration papers will be stamped with seal of the IBBA with the date of the inspection. In future shows, this registration certificate with the seal will need to be presented at check in for identification purposes only. If this registration certificate is presented with the seal of the IBBA, the additional inspection of a brand or ear tattoo is not required. If a new or unstamped certificate is presented, the animal's identification must be verified again before a stamped is received again.
8. Any animal is subject to recheck by the IBBA Ethics Committee at any show at any time.
9. Any animal upon check in which does not have a legible tattoo or brand corresponding to its registration certificate is ineligible to show. An animal may be tattooed immediately at a show for reinspection.

## Parent Verification

10. All animals are required to have complete parent, both sire and dam, verification on file at IBBA prior to the show check-in. If an animal does not have **DNA parent verification** completed at that time, they will be ineligible to show. DNA parent verification is defined as having submitted DNA samples per the IBBA DNA testing process of the animals being entered, their sire and their dam, and then having the show animal's genotype match to that of both parents as determined by the IBBA.
  - a. If the calf at side is over 90 days of age by the date of show check-in, it must have parent verification completed by show check-in. If it is under 90 days, parent verification of the calf is not required.
  - b. Cows in the cow/calf pair classes are exempt from the parent verification requirement if they are born prior to September 1, 2016.
11. IBBA reserves the right to collect DNA samples at any IBBA-sanctioned show. Collection will be conducted by random draw for retesting of parentage at the association's expense. At the six national IBBA-sanctioned shows, three random samples will be collected from Brangus and UltraBlack entries and three random samples will be collected from Red Brangus and UltraRed entries. An animal found to not match the stated pedigree must resolve the question before it is allowed to show again. I

### **Physical Inspection and Eligibility**

12. Prior to check-in, heads of exhibited animals must be clipped of all hair, including topknots and be free of scurs and/or slick spots. Animals not in compliance at check in will be required to comply before check in is complete, or they will not be allowed to show.
13. Any animal found to have scurs and/or slick spots; or evidence of incisions, surgical or otherwise, in the following areas: head, testicles, sheath, navel, or dewlap; including scars from caesarean sections, will be disqualified from showing. They shall be disqualified at the show where the violation is determined and all future IBBA sponsored and sanctioned shows. A veterinary statement of purpose or cause will not be accepted.
14. Animals with illegal white (defined as white in front of the naval) or any indication of brindling (a color pattern characterized by red streaks mingled with black), or red animals with any unacceptable coloring (according to the IBBA Red High Color Scale – available at [gobrangus.com](http://gobrangus.com) – and including Brown, Grey, Yellow, Light to White, White Legs or Black Muzzle) are ineligible for show at the show in which the color issue is found. The animal is eligible for inspection at future shows.
15. No animal may be shown that has been pumped with any amount of liquid at any time once the animal enters the grounds of a show. The official show veterinarian may administer liquids orally, if so needed, without disqualifying animal(s) from exhibition.
  - a. A protest of this violation must be submitted per the Violation Policy
  - b. Penalty: The fitter and ranch entity involved with an animal being artificially filled will be banned from the show ring for one year and the animal will be disqualified from exhibition at that particular show.
16. All entries may be classified for judging on an age basis and should be entered in class according to age. Teeth may be inspected by a veterinarian designated by the IBBA in order to determine whether dental development is within allowable limits for the class so entered. If the veterinarian determines that in his opinion dental development exceeds maximum allowable limits, the animal shall be disqualified from the show where the error is determined and all future shows.

### **Fitting and Presentation**

17. Animals unethically fitted to alter the conformation or appearance of the animal, as determined by the appointed IBBA Ethics Committee or IBBA Staff, will be immediately disqualified at the show in which the violation occurred. This includes:
  - a. No animal may be shown that has had any foreign objects, glued to or otherwise attached in a manner so as to alter its conformation or change its appearance.
  - b. Paint or coloring agents of any kind are not to be used on any animal exhibited at IBBA sponsored shows.
18. All bulls must have a nose ring or nose restraint with the lead attached at all times, with the exception of being tied in the stalls and tie outs. This includes but is not limited to being in the show ring and during check in. Bulls 250 days and younger are exempt from this requirement.
19. Unruly animals that cannot be kept under control will be disqualified at the said show. If an animal breaks away from its handlers three times, they will be dismissed from the show ring and not eligible to show at that particular show.

### **Fertility and Performance Requirements**

20. Weights and scrotal measurements will be taken on all bulls at check-in at all six of the IBBA National Shows.
21. All Brangus bulls 18 months of age or older that are exhibited at IBBA sponsored shows must have passed a fertility examination given by a non-owner licensed veterinarian or a non-owner certified technician to the standards of the Society of Theriology to be eligible to show. The results of the examination must be available at check-in. Once a bull has a positive examination, retesting is not required.

22. All females 20 months of age or older exhibited at IBBA sanctioned shows, must have available at the time of check-in, a certificate of pregnancy issued by an accredited non-owner veterinarian, non-owner certified professional or blood test results certificate. If a blood tests results certificate is provided, it must be blood collected by a non-owner veterinarian or non-owner certified professional, and documented. If the female is open due to being in an embryo transfer program, a certified copy of the flush record showing viable embryos produced by the said female must be presented at check-in, by a non-owner embryologist. If verification cannot be produced, the female will be allowed to participate if the exhibitor can produce a qualified veterinarian to examine the female at the show site and verify pregnancy. Females showing in the Senior Heifer Division of Spring Shows (January 1 through May 31) must adhere to the classifications and have an IBBA registered natural calf, not older than 250 days of age on show date.

### **Show Rules Violation Policy and Penalties**

23. The IBBA and its representative have the authority to request and require such tests as they deem necessary to verify the accuracy of the classification, pedigree of exhibited animals and enforce all show rules as adopted by the IBBA. IBBA representatives shall include the appointed Ethics Committee at each show. A decision by the Ethics Committee and/or the IBBA representative shall stand at the show in which it is made.
24. Owners are responsible for any infraction committed by a non-member or anyone employed or contracted by the owner.
25. A valid show rules violation complaint must be accompanied by a written statement describing the violation, the perpetrator of the violation, and signed by an active member of the IBBA. This written complaint will be presented to an Ethics Committee consisting of the Chairman of the Show Committee and the three person Ethics Committee that has been previously appointed for the show where the complaint is presented. All four people will be current members of the Show Committee.
26. The Ethics Committee shall rule on the validity of the rule violation. The Ethics Committee shall visit with the perpetrator, present the written complaint, and make a ruling on the complaint if valid. The penalty will be applied according to each stated rule above.
27. The perpetrator is entitled to appeal any decision made by an IBBA representative, Ethics Committee, a veterinarian, certified industry professional or designated association representatives to the IBBA Board of Directors. The following requirements must be met: 1) the appeal is in writing and is signed by the appealing party; and 2) the appealing party files the written appeal with the IBBA Board of Directors as soon as possible after the decision is rendered however, the ruling will stand at the show in which the violation occurred. If the IBBA Board of Directors over turns the ruling of the Show Committee Ethics Committee, the exhibitor and or animal in question will be allowed to return to future shows. The IBBA Board of Directors has the right to disqualify the perpetrator from the IBBA approved show after hearing an appeal. The IBBA's Board of Directors decision is final.
28. Entries that have not complied with all of the above rules will not be eligible to show, to receive premium monies, or earn points in the IBBA's Show Sire of the Year, Show Dam of the Year, Show Bull of the Year, Show Heifer of the Year and Show Cow Calf Pair awards.
29. For and in consideration of the opportunity to participate in any function each exhibitor hereby releases the Association, its officers, directors and representatives from negligence, any and all claims, suits, and judgments past, present, or future, arising from or connected with the administration or use of such test or examination and the resulting decision there from.

### Presentation of Classes for International Brangus & Red Brangus Shows

An IBBA National Point show shall be conducted in the order described below. Regional and non-Point Show may choose to conduct a show in a difference manner.

IBBA National Point Show class order:

- I. The Brangus Show will begin with the Black Female classes. Junior Heifer Calf classes will be judged through Junior Heifer Calf Champion and Reserve Junior Heifer Calf Champion.
- II. Then, the Red Female classes will enter the ring and will be judged through Junior Heifer Calf Champion and Reserve Junior Heifer Calf Champion.
- III. This procedure will be alternated between Black and Red Shows until all age champions have been selected.
- IV. After this, the Black Female Age Division Champions (Junior Heifer Calf Champion, Senior Heifer Calf Champion, Summer Champion Heifer, Yearling Champion Heifer and Senior Champion Heifer) will be brought back to the ring for the Black Female Grand Drive. The judge will select the Grand Champion Black Female and Reserve Grand Champion Black Female.
- V. Upon completion of the Black Grand Drive, the Red Female Age Champions will be brought back to the ring for the Red Female Grand Drive.
- VI. The Cow/Calf classes will begin with the Black females. The Black Cow/Calves will be judged through Champion and Reserve
- VII. Champion Cow/Calf. Then, the Red Cow/Calf classes will be judged through Champion and Reserve Champion Red Cow/Calf.
- VIII. The above procedure will be followed in the bull judging, beginning with the Black classes and alternating between Red and Black Shows. If a division does not have any cattle entered, the division will be skipped.
- IX. Group classes will be judged with Black Group Classes all being exhibited first, followed by all Red Group Classes.

## **SPECIAL RULES**

1. All animals to be eligible for an Open Charolais Breeding Class must be purebred and registered with the American International Charolais Association (AICA). Only bona fide (original) certificates of registration will be accepted as evidence of registration and ownership; **NO PHOTOCOPIES.**
2. An animal is eligible to enter or compete in an open Charolais breeding class if registered in country of origin outside the United States and is eligible for purebred registry in the AICA Herdbook.
3. All animals to be eligible may be approved by a sifting committee designated by the AICA. Stall space will not be provided for any Charolais cattle that have not been accepted by the sifting committee.
4. All animals are subject to a medical examination in order to determine age, and each animal will be present in the show ring in its natural conformation without alteration or modification. Use of artificial tailheads is not permitted.
5. Any animal not having a legible tattoo or firebrand number is ineligible and will be barred from showing.
6. Bulls from classes 40, 41, 44, 45, and 46 must have a valid, satisfactory semen test certificate in possession. This certificate is valid for the entire show season.
7. All animals shown in individual classes must be weaned, with the exception of the Cow-Calf Class and calves at the side of females calved after September 1, 2021. Calves must be purebred and registered with the AICA. Females calved after September 1, 2021, must show in individual female class appropriate to age. Nurse cows are not permitted.
8. All females 20 months and older exhibited at AICA sanctioned shows must be accompanied by a certificate of pregnancy from a licensed veterinarian or have produced fertile eggs as certified in a written statement by a licensed veterinarian or embryologist or have a calf at side.
9. AICA requires that all animals be shown with a halter and suggests that all bulls be shown with a nose lead.
10. **ALL EXHIBITS OF CHAROLAIS BREEDING CATTLE SHALL BE GOVERNED BY THE AICA RULES AND REGULATIONS, ARTICLE XV, TITLED EXHIBITION OF ANIMALS. THE INSPECTION OF EXHIBIT CATTLE IS SPECIFIED IN ARTICLE XV, PARAGRAPH C, OF THE ASSOCIATION RULES AND REGULATIONS AND NON-COMPLIANCE OF EXHIBIT INSPECTION IS SPECIFIED IN PARAGRAPH D OF THE SAME ARTICLE XV.**

ARTICLE XV, PARAGRAPH B, POINT 2: "Each animal will be presented in its natural conformation and structure without alteration or modification. Alteration or modification shall be defined to include any surgical, chemical, electrical or other (including banding or other circulatory constriction) change for cosmetic purpose, save only branding, tattooing, foot trimming or dehorning. The act of artificially filling animals internally, which would include stomach pumping, drench tubes, or any other method per os (by esophagus), is prohibited. Silicone injection or other injection for cosmetic purpose shall be prohibited. Anabolic steroid use shall likewise be prohibited and any animal testing positive for anabolic steroid or diuretic use shall be presumed to be altered and modified."

**Effective October 22, 2004, at any American-International Charolais Association (AICA) sanctioned show (including shows receiving AICA premium funding and/or qualifying as a Roll of Excellence Show), the use of a coloring agent, flock and powder is prohibited. Use of these products will result in the immediate disqualification of a given animal at such show.**

The 2025 Dixie National will include an Open Gelbvieh Show with an Open Balancer Show beginning 15 minutes after the Gelbvieh Show. The same rules will apply for the Balancer as for the Gelbvieh.

## **Open Gelbvieh Show Rules**

1. All animals exhibited must be recorded in the name of the exhibitor prior to entry deadline. A copy of the registration paper or an affidavit of registration must accompany each entry to show.
2. Animals are placed in the category based on the rule of the year that animal was born: "Gelbvieh females sixty-nine point one (75%) percent to one hundred (100%) percent will show together in the Gelbvieh show. Gelbvieh bulls sixty-nine point one (75%) percent to one hundred (100%) percent will show together in the Gelbvieh show. A Gelbvieh female or bull that is at least 75% Gelbvieh or more and qualifies for the Balancer® trademark can choose whether to show as Gelbvieh or Balancer at the time of entry. To qualify for the Balancer® Show all cattle must meet the American Gelbvieh Association's Balancer trademark rules for registration as a Balancer.
3. Cattle must be entered and exhibited under the recorded ownership at the time of show deadline date. Jointly owned animals must be entered and shown under the multi-ownership (all co-owners) in the individual classes.
4. All animals must either be properly tattooed, including herd prefix and will be inspected at the show. If the tattoo is illegible or does not correspond to registration certificate, the animal is ineligible to show or may be re-tattooed by the exhibitor and re-checked at the end of processing. EID numbers will be accepted as permanent forms of animal identification but must be printed on the animals registration paper.
5. All cattle must meet the health requirements set out by the Show Management. Any deviation from the health requirements will be just cause for immediate disqualification from the show.
6. Show committee prohibits the use of powders of any color, false tailheads and glued-on hair or hair-like substances.
7. All bulls must show with a nose lead. Entry into the show ring without one will be an automatic disqualification. The right to disqualify from the show any animal deemed unmanageable is reserved by the show committee.
8. Age of calf at side in cow/calf class must not exceed two hundred forty (240) days as of date of show. Calf must be natural calf, not an embryo transfer calf.
9. Any person found guilty of misrepresentation, or not abiding by the show rules will be disqualified and denied the privilege of showing.
10. Classes will be split as evenly as possible after processing. Splits will be decided using the total entries at processing.
11. It is expected and required that all parties involved in any Gelbvieh or Balancer show shall respect, cooperate, and be courteous to the judge, show management, exhibitors, the American Gelbvieh Association, AGA staff, and spectators before, during, or after a show. If an exhibitor, employee, or family member of exhibiting operation should violate this via phone call, text message, email, social media, and/or in person, that operation will be removed from the show and/or be banned from exhibiting in any Gelbvieh or Balancer show for a year including AGJA Junior Nationals and the National Gelbvieh and Balancer show. Any Gelbvieh or Balancer animal co-owned by offending operation will also not be allowed to be exhibited at any AGA sanctioned show for that year.

## **Approved Breed Standard – Texas Longhorns**

The most distinctive feature of the Texas Longhorn is the horn. Horns should be of moderate diameter, with the diameter of the horn not to exceed that of the poll. Females should have out swept horns with twist or curl preferred. Males can have a wide variety in shape and angle of horn. Horns less than 48” (4 feet) at maturity for both sexes are highly objectionable. Exhibition steers, regardless of age, are considered trophy steers (not market steers) and should have exceptional length or shape to the horn.

The head should be of moderate to pronounced length with moderate width across the forehead and a wide muzzle, giving an almost rectangular profile. The ears will be small and held close to the horn. Long hair in the ear is preferred. The neck should be trim in females and well-muscled in bulls, with no evidence of hump, and should blend in well at the shoulder.

The neck should be trim and tie in smoothly in both sexes. The bull should have a crest over the midpoint of the neck. The shoulder should be free with a moderate slope in both sexes. The topline should be strong and level with good width. Trophy steers may have a slight downward slope from the shoulders to hips. The hip should have a moderate slope from hooks to pins. Level hip/elevated pins or sharply sloped hips should be severely discounted. The tailhead should be balanced and neither square or overly sloped exhibiting a characteristic “fish hook” in the sacral vertebrae. The tail should be long and straight with a tail switch that reaches to at least the mid cannon and preferably the fetlocks at maturity.

The body should be deep in relation to the length of spine with balance between the heart girth and flank depth. Trophy steers will have a deeper heart girth in relation to flank depth. Ribs should be well sprung. The brisket should be clean and free of excessive fleshiness with moderate width.

The feet and legs should be strong with a large foot and well angled pasterns. There should be a moderate set to the hock when viewed from the profile. Fore and hind feet should point forward, being neither pigeon toed nor splay footed. Both sexes should have a strong stride with no knuckling of the pasterns, the rear foot should track precisely in the footprint of the fore foot. Upright pasterns or “post legged” animals are highly objectionable. Excessive space between claws is objectionable.

Muscling should be smooth in both sexes. The topline should be broad when viewed from the rear with good width of loin. The musculature should be carried well down the stifle in the rear and into the forearm on the fore. The hip should be well muscled without appearing square. Larger horned animals may have increased musculature in the neck, to support the increased head weight, but should still maintain appropriate smoothness.

The haircoat should be slick and short (seasonally) as Longhorn cattle are not considered haired cattle. Coat patterns and colors are extremely varied.

The underline should be clean with no prominent navel/prepuce or excessive flesh. The udder should be attached well forward in the front quarters and high in the rear quarters. The udder floor should be level with evenly spaced teats of a small diameter and short to moderate length. The teats should not extend below the level of the hock. Testicles should be even and of an appropriate circumference for age. Testicles should hang level and not show any evidence of twist.

Overall, the animal should appear well balanced and functional. Traditional Longhorn conformation traits are centered around ensuring longevity. The preceding breed standard was created to preserve and promote the characteristics that maintain the identity of the Texas Longhorn.

## Special Rules for Open Miniature Hereford Show

1. All exhibitors must be a current paid member of the MHBA to be eligible to show.
2. All entries must be registered with the American Hereford Association. Animals with “Pending” or “Applied for” registrations at the date of the show are not eligible to compete.
3. Animals must be under the ownership of the entrants name with the AHA for a minimum of 30 days prior to show date, with approved exceptions by the Show Superintendent.
4. All entries (including Cow/Calf pairs) will be measured, with no exceptions. Maximum height allowed to be shown in these classes is 45” on females and 48” on bulls and steers.
5. Any animal exceeding the height limit will not be eligible to show.
6. All horned and polled Miniature Hereford cattle will show together.
7. The show superintendent reserves the right to combine or split classes depending upon total entries in class.
8. Any animal without the correct, legible tattoo will not be eligible to show.
9. One exhibitor per animal is allowed in the show ring. Exhibitors with disabilities must communicate their needs to the Show Superintendent prior to show and will be pre-approved for limited assistance in the show ring.
10. Classes will not be held for late exhibitor arrivals.
11. Exhibitors or cattle that disrupt the class will be removed.
12. Use of hemp hair, removed hair, or other hair-like materials added to the animal’s body will not be allowed.
13. MHBA does not allow surgical or any other alterations (except dehorning) to the animal that alters the animals original color pattern and conformation. Exhibitors found in violation of this rule will be disqualified from the show.
14. No artificial filling (pumping/drenching) of animals will be allowed unless under the advice of a licensed, non-owner veterinarian. Exhibitors found in violation of this rule will be disqualified. Medicating with drench guns may be allowed.
15. If an animal’s registration has been obtained through misrepresentation or fraud, or if the date of birth, tattoo number, sire, dam or service information, or any other fact regarding the animal has been intentionally misrepresented, the entry and exhibitor will be disqualified from the event in its entirety and will not be allowed back for a period of two calendar years. This applies to all of the exhibitors’ entries at that show.
16. The MHBA reserves the right to DNA any cattle being shown. Should testing reveal that the animal has been misrepresented on its registration papers, the exhibitor will be disqualified from the MHBA event in its entirety and will not be allowed back. This applies to all of that exhibitor’s entries.
17. Site-specific protests must be filed at the MHBA Sanctioned Show. Any person wishing to have an animal inspected is required to submit a written protest accompanied by a non-refundable \$500.00 fee paid in cash or by cashier’s check written to the MHBA. The person placing the protest is responsible for all costs incurred to verify the protest. Written protest must state plainly the cause of the complaint and must be filed before the championship drive at the sanctioned show. Protests will be handled by the Board of Directors from the MHBA or the current Show Superintendent and show committee.
18. All persons making entries in a MHBA sanctioned show, participating or attending said event do so at their own risk and agree to abide by all the rules and regulations and will not hold the Miniature Hereford Breeders Association, the Miniature Hereford Youth Foundation, or any person's or companies associated with this event responsible for any and all accidents to any person, animal, article, or personal property.
19. All exhibitors must adhere to the Code of conduct and Liability statement

**Heifer Show Rules:**

1. Heifers must be registered with the American Hereford Association.
2. All general rules will apply to the heifer show i.e. ownership, participant age, fitting, etc.

**Cow/Calf Pair Rules:**

1. Cow/Calf Pair’s must be registered with the American Hereford Association.
2. There is no maximum age for cows.
3. Cow must be measured for height and not exceed 45” at the hip.
4. Calf must be natural calf, no more than 270 days in age as of the day of the show.
5. Polled and horned pairs will be combined in one cow/calf show.
6. Calves on the side of cow-calf pairs MUST BE the cow’s natural calf
7. Calves at the side of cow-calf pairs must be shown in separate heifer, bull, or steer classes if classes are offered by the venue.
8. All calves on the side of the cow-calf pairs must be registered and tattooed.
9. All general rules will apply to the cow/calf show i.e. ownership, participant age, fitting, etc.

**Bull Rules:**

1. Bulls must be registered with the American Hereford Association.
2. A bull over one year of age is required to have a ring in his nose (permanent or removable bug).
3. All general rules will apply to the bull show i.e. ownership, participant age, fitting, etc.

**Steer Rules:**

1. Effective January 1, 2024, steers must have a DNA profile on file with complete parentage verification (dam and sire verification) with the American Hereford Association before show entry deadline.
2. Prospect steers will not have exceeded one (1) year of age as of the day of the show exhibiting.
3. Market Steers must exceed one (1) year of age and not exceed twenty four (24) months as of the day of the show exhibiting.
4. All steers must be registered with the American Hereford Association. The registration paper must state Steer and be issued in the name of the exhibitor. No steer certificates will be accepted, only registration papers.
5. All Steers may be no greater than 48” at the hip.
6. Steer classes will be sub-divided by weight. Classes will be determined after check in, weights, and height measurements.
7. All general rules will apply to the steer show i.e. ownership, participant age, fitting, etc.

**Bred and Owned Rules:**

1. To show in a “Bred and Owned” show, the animal must be bred by the exhibitor (must own cow at time of breeding), and owned and shown by the exhibitor. For embryo transplant (ET) calves, the exhibitor must have been the owner of the dam at time of the flush and the exhibitors name must be listed as the “breeder” on the animals AHA registration paper.

1. APPLICATION OF SHOW RULES AND CLASSIFICATIONS
  - a. The Rules and Regulations set forth in Section J of the Red Angus Association of America (RAAA) Rules and Regulations apply to all RAAA sponsored shows:
    - i. Non-RAAA sponsored shows may use any portion of the RAAAShow Regulations and Classifications, but neither RAAA nor its staff will be responsible for interpretation or enforcement of said regulations/ classifications, nor play any role in conducting a non-RAAA sponsored show.
2. OWNERSHIP REQUIREMENTS (Rev 6-11)
  - a. All animals entered will:
    - i. Have at least one owner on record as a Regular or junior member of RAAA.
    - ii. Be registered with RAAA and meet all requirements for Category 1A or 1B.
      - i. Have Official registered Status at the time of processing.
  - b. Ownership requirements are also subject to the rules and regulations of the hosting exhibition.
  - c. Substitutions will only be permitted for animals already entered and within class, according to the hosting show's deadline, **but no later than 10 business days** prior to the date of processing.
3. GENERAL REGULATIONS
  - a. Entries are accepted with the understanding that each exhibitor agrees to conform to the rules and regulations of the RAAA. Enforcement will be at the discretion of the RAAA authorized representation and may include barring an animal or exhibitor.
  - b. Exhibitors shall exhibit sportsmanship and professional behavior in and around the show ring. Abusive, discourteous, or threatening behavior towards judges, show officials, fellow exhibitors or RAAA authorized representatives will not be tolerated.
  - c. All animals must have legible tattoos which match the Animal ID and Herd Prefix as recorded in the RAAA database prior to processing.
    - i. Animal ID and Herd Prefix verification may be via printed registration certificate or real time electronic representation of the RAAA database.
  - d. Each animal will be exhibited in its natural conformation and structure and without any alterations or modifications, with the exception of acceptable fitting and grooming practices.
  - e. The use of coloring agents, paints, and/or the addition of any hair or hair-like substances will not be allowed.
  - f. No pumping
  - g. At the time of processing, all females 20 months of age or older on publicized date of show must have one of the following:
    - i. Certificate of pregnancy from a licensed veterinarian
    - ii. Written statement by a licensed veterinarian or embryologist of having produced fertile eggs
    - iii. Female's own natural born calf at side, which need not be registered, but must be eligible for category 1A or 1B registration in the RAAA
  - h. All bulls 9 months of age or older (on announced date of show) exhibited at a show sponsored by the Red Angus Association of America must be shown with a nose lead.
  - i. After processing, should the number of entries in any class exceed practicality, authority representative of the RAAA have the authority to "split" classes according to age and the date of birth that best encourages fair competition.
  - j. Any calf exhibited at the side of their dam in a cow/calf class may be exhibited in an individual class subject to all pertinent RAAA Show Rules and Classifications
  - k. Any exhibitor who loses control of his/her animal twice in the show ring will be required to remove the animal from the show ring.

## 4. DECLARATION OF PARTICIPATION

Each exhibitor is subject to the following “Declaration of Participation” in accordance with the Rules and Regulations of the RAAA:

“I/We, as exhibitor of Red Angus, having made entry application to any Red Angus show or exhibition do hereby agree:

- “To make our cattle available to any tests or examinations called for by authorized representatives of the RAAA or show officials with regard to acceptability of the cattle to be exhibited in the show.
- “To release the RAAA, its Board of Directors, staff and authorized representatives, from any claims for damages resulting from any such examinations or tests requested by authorized representatives of the Association or show officials.
- “To retain the right to challenge the results of any such examination or test in due course and under the provisions of the Right to Appeal, in accordance with the Rules and Regulations of the RAAA”.

## RULES AND REGULATIONS

All exhibits of Santa Gertrudis breeding cattle must be registered or recorded (50% - 75% with one parent a registered Santa Gertrudis), meeting the requirements for registration or recordation as outlined in the Santa Gertrudis Rules and Regulations for Registration, and shall be governed by the last revised version of the Rules and Regulations for Approved Santa Gertrudis Open and Junior Shows as approved by the Board of Santa Gertrudis Breeders International, P.O. Box 1257, Kingsville, TX 78364. A copy may be obtained by contacting the association or viewed at [www.santagertrudis.com](http://www.santagertrudis.com).

- a. Each owner must be a member in good standing with SGBI. No outstanding balances on an active or junior members account.
- b. **ALL** animals accepted for exhibition in an SGBI sanctioned show are subject to inspection at each show between arrival on grounds and prior to entering the show ring. The inspection will be conducted by a committee comprised of two (2) members of the Shows and Exhibits Committee and one (1) from the Breed Standards Committee.
- c. Heifers twenty-four (24) months of age or older must be safe in calf as verified by a graduate veterinarian or have produced a live, Santa Gertrudis sired calf with that calf at side meeting the Standard of Excellence and the calf must be registered by thirty (30) days of age. If the animal is open due to being an embryo transfer program this fact must be verified by a written statement signed by a licensed embryo technician in order to show.
- d. All late summer yearling bulls and older must be exhibited with a nose ring or nose clip.
- e. All animals must be registered or recorded and **PERMANENTLY** identified **before the show** with a brand ID or an ear tattoo.

## JUNIOR OWNERS AND POSSESSION RULE

- a. To be eligible to compete in SGBI approved junior shows, animal(s) must be registered or recorded in the name of the junior member. This registered or recorded junior must feed, fit, care for and show the animal entered. Ownership deadline is April 1<sup>st</sup> for all animals born January 1<sup>st</sup> of the preceding year and thereafter, and November 1<sup>st</sup> for all other animals.
- b. Juniors participating in Open Shows are allowed and encouraged. Entry must be shown by owner or family member (sister, brother, mother, grandparent, legal guardian, relative by blood). No animal may be fitted or shown by any open exhibitor at any time during the junior's ownership period. An exception is transportation, feed, and care to a show for the duration of the show. In the event of an emergency another junior member may show the animal with the approval of the Shows and Exhibits Chairman or his/her representative.

## FITTING

- a. Purebred fitting – All purebred animals must be exhibited with the hair brushed down on the entire body, legs, and tail with no foreign objects attached to the animal in a manner as to alter the animal's conformation or change its appearance. Exhibitors failing to abide by this rule will not be allowed to show. *Specifically, all hair must be brushed down slick; head clipped smooth; underline clipped blending sides; udder and teats clipped with no long hair to emphasize udder; ears clipped as to environmental and local standards; neck and brisket clipped; body clip using common sense as to season; leg hair clipped and do not leave long from hock or knee to hoof; tailhead clipped; pull switch or brush out (no ball, etc.) trim tail to personal preference.*
- b. **Star Five fitting** – Star Five exhibits are not subject to purebred clipping rules. Entries are to be fitted blow and go. Hair may be brushed according to preference with no foreign substances/fitting materials on any part of the body.

Each animal exhibited must be exhibited with the correct age and shown in the class corresponding with their correct age.

- a. Entries in each class will be placed 1, 2, 3, etc. Animals are to be presented in descending order according to age.
- b. Polled classes will be entered at the same time as class entries are required by each show. Animals will be lined up according to age for the judge. To be eligible to show in Best of Polled, animals must be slick polled with no scurs, no scars, no dehorning and with no evidence of horny tissue.
- c. Classes with over thirty (30) entries will be divided into sections and section winners return for final placing.
- d. The judge SHOULD be an SGBI approved judge.
- e. Dress for exhibitors participating in SGBI sanctioned Open and Junior shows shall be of neat and clean clothing of collared shirts with sleeves, belts, no midribs showing and appropriate footwear – no tennis shoes. Exhibitors may wear hats or go bareheaded – no caps.
- f. Each animal shall be presented in the show ring in its natural conformation and structure without alteration or modification. Alteration or modification shall be defined to include any surgical, chemical, electrical, other appearance change, save only branding, tattooing, foot trimming or dehorning. Additionally, no pumping or filling of any animal with a liquid, air, or any other substance is allowed. ALL animals and exhibitors found to be in violation of this rule will be banned for life from showing at SGBI approved shows.
- g. If entries are not properly fitted and good herdsmanship followed, the owner may be asked to not display their cattle until adhering to the proper procedures as outlined in our herdsmanship paper.
- h. Every exhibitor, in consideration of his/her entry being accepted, agrees to submit any animal so entered by him/her to inspection and agrees to have such animal submitted to any tests as may be designated and requested by the Shows and Exhibits Committee, or the authorized representative of the relevant show or fair, and agrees that the conclusions reached by the committee/representative as to whether such animal is unethically fitted or over age, shall be final, without recourse, against SGBI and designated personnel. Any false representation, interference or unprofessional conduct on the part of any exhibitor will be dealt with by the Shows and Exhibits Committee according to the equities in the case.
- i. For and in consideration of the opportunity to participate in any SGBI approved show, each exhibitor hereby releases SGBI, its officers, directors and representatives from negligence, any and all claims, suits and judgments, either past, present or future, arising from or connected with the administration of use of such test or examination and the resulting decision therefrom.
- j. Any exhibitor desiring to dispute or challenge the results of any test, exam or show rule enforcement, as applied by his/her animals, shall do so in accordance with procedures established by the rules of the association. This refers to, but is not limited to, the procedures to file protest and appeals process.

#### **APPEALS:**

- i. The Chairman of the Shows and Exhibits Committee and the Vice-President of Youth Activities in conjunction with the person(s) responsible for coordinating the individual shows will continue to be primarily vested with authority to determine whether animals entered in shows meet the standards formally approved by the Breed Standards Committee.
- ii. In the event the Vice-President of Youth Activities or individual show coordinating official disqualifies an animal from participating in a youth show and the exhibitor wants to appeal the disqualification, the appeal process outlined below must be followed.
- iii. In the event the Chairman of Shows and Exhibits or individual show coordinating official disqualifies an animal from participating in a sanctioned show, and the exhibitor wants to appeal the disqualification, the appeal process outlined below must be followed.
- iv. Additionally, **any** exhibitor participating in an individual youth show or other SGBI sanctioned show that wants to appeal a breed standards disqualification decision by either the Vice-President for Youth Activities/youth show coordinating official or the Chairman of Shows and Exhibits/show coordinating official must follow the appeals process outlined below.

### Appeals Committee

The Appeals Committee will be comprised by the following three (3) members – the Vice-President of Breed Improvement, the Vice-President of Marketing and Promotions and the Executive Director of SGBI. All three (3) members must be present to constitute a quorum. All decisions rendered by the Appeals Committee will be binding and final for all appeals submitted to the committee.

### Appeals Procedure

- a. All qualification/disqualification appeals, and appropriate supporting documentation submitted by exhibitors must be submitted in writing to the Executive Director of SGBI. The written appeal must be accompanied by a \$200 process fee. No waivers will be granted to the requirements for written appeals and the up-front \$200 fee.
- b. Exhibitors must file written appeals postmarked or via e-mail with five (5) business days following the date of the show governing the qualification/disqualification decision by the primary officials (Vice-President of Youth Activities/show coordinating official or Chairman of Shows and Exhibits/event coordinating official).
- c. The Executive Director will be responsible for coordinating meetings of the Appeals Committee and forwarding copies of the appeal and supporting documentation to the other committee members.
- d. The Appeals Committee will render a final decision within five (5) business days following receipt of the written appeal, appropriate supporting documentation and the \$200 fee.
- e. In the event an exhibitor appeals a disqualification decision by the primary official and the Appeals Committee **approves** the exhibitor's appeal, the animal covered by the appeal will be qualified to participate in all future SGBI sanctioned events.
- f. In the event an exhibitor appeals a disqualification decision by the primary official and the Appeals Committee **disapproves** the exhibitor's appeal, the animal covered by the appeal will be disqualified from participating in future SGBI sanctioned events. Additionally, any points or awards previously given to the owner of the animal will be forfeited.
- g. In the event an exhibitor appeals a qualification decision by the primary official and the Appeals Committee rules that the animal covered by the appeal **does not** meet breed standards, the covered animal will be disqualified from participating in future shows and the owner of the animal will forfeit any points and awards previously granted.

### PROCEDURES TO FILE PROTEST:

1. File protest with show that infraction occurred. Follow their protest rules
2. File the same protest with the Shows and Exhibits Committee. Contact the chairman.
3. Three (3) SGBI members in good standing must sign the protest.
4. All protests must be in writing and accompanied by a deposit of \$100.00, cash or certified check, which will be forfeited if protest is not sustained. Such protest must state plainly the cause of the complaint or appeal and must be delivered to the Shows and Exhibits Committee within twenty-four (24) hours after the occasion for such protest.
5. Order of hearing a protest:
  - a. Chairman of Shows and Exhibits Committee
  - b. Action by Shows and Exhibits Committee
  - c. Final action by Board of Directors
  - d. Follow appeal procedure as outlined in Rules and Regulations.
6. All rules and regulations that have been properly protested to the Shows and Exhibits Committee shall be subject to the following penalties:
  - a. Loss of premium money.
  - b. Loss of awards.
  - c. Suspension from showing the subject animal as deemed necessary. Penalty may be for one (1) show, two (2) shows or three (3) Shows, or as long as deemed necessary for the offense.
  - d. Suspension of the exhibitor being the same as other SGBI Rules and penalties.
  - e. Failure to adhere to each show's specific rules shall also be subject to these penalties. Proper protest procedures must be adhered to according to that particular show's rules. SGBI will follow each

show’s rules, and any action taken by a show will be upheld by SGBI in relation to its bearing on our point show system.

**DISQUALIFICATIONS:**

- An exhibitor who has been disqualified from competition in any livestock show or has had a premium withheld or withdrawn on the grounds of rule violation(s) will not be allowed to compete in other shows. This shall include, but not limited to, disqualification for fraud, misrepresentation, unethical fitting or deception.
- Judging procedures will **NOT** be interrupted for protest investigation. Depending on the basis of the protest, a decision may be withheld until a thorough investigation is completed. No complaint or appeal regarding a judge’s decision or method of selection will be considered.
- Show officials may excuse an exhibitor from the ring and exclude them from further competition if an exhibitor, in any way, whether in person or by their representative interferes or shows disrespect to a judge or show official.
- In the event that an exhibitor or animal is disqualified after they have been awarded premiums or awards, the exhibitor or animal placing immediately below them may be moved up to fill the vacated position at the discretion of the Shows and Exhibits Committee.

**RULES FOR HIGH POINT AWARDS:**

- a. For each point show, first place class winner will receive two (2) points; second place class winner receives one (1) point; Division Champion receives three (3) points; Reserve Division Champion receives two (2) points; Grand Champion receives five (5) points and Reserve Grand Champion receives four (4) points; Best of Polled receives one (1) point but does not count toward overall points.
- b. Get of Sire and Produce of Dam points go toward Exhibitor/Breeder of the Year Awards.
- c. Points will stay with animal if sold.
- d. The Sire and Dame of the Year should have points from at least two (2) different offspring.
- e. All points earned at the National Open Show are to be doubled.

**DNA Testing**

SGBI and its representatives have the authority to require such tests as they deem necessary to verify the accuracy of the classification, pedigree of exhibited animals, and parentage verification of Star 5, including calves exhibited at the side of any female. “Said authority shall extend to and cover the enforcement of all show rules as adopted by SGBI.”

8. At the discretion of Mississippi Simmental-Simbrah Association, each bull 15 months of age or older must have a current semen test/breeding soundness exam and show to be a satisfactory breeder. The test must be done within 60 days prior to the show date. Each female 18 months of age or older must be: a.) certified pregnant by a licensed non-owner veterinarian, b.) have certification that she has been used in embryo transfer, or c.) have a calf at side. Documentation must be provided to an MSSA official before the animal is eligible to show.
9. Grand and Reserve Champions will have DNA samples pulled and tested for parentage and genomics. ASA reserves the right to pull additional samples on any animal exhibited. DNA collection will occur at the exhibition site and will be supervised and/or conducted by ASA staff. Failure to submit to DNA testing will result in automatic disqualification.
10. Heifer classes will consist of females born January 1, 2023 through June 30, 2024. Bull classes will consist of bulls born January 1, 2022 through June 30, 2024. Cow/calf classes will consist of cows born before January 2023 with a calf at side no older than 205 days of age on the day of the show. Any female that qualifies by age for the heifer classes is not eligible for the cow/calf show.
11. Females and bulls will be judged youngest to oldest with no more than 15 head per class. All animals must be in the makeup area prior to the conclusion of the prior class or division. Any animal not ringside when its class enters the ring will be scratched from that class.
12. ASA and MSSA reserve the right to bar any animal or exhibitor from the show that does not meet the requirements of this show.

## **RULES**

1. Entry form and fee will be completed online through the website. Entry fees \$30.00 per entry until January 24, 2025. All fees payable through website.
2. All animals must be registered with either the American Wagyu Association, The Australian Wagyu Association, or the Akaushi Association and recorded in the name of the exhibitor 30 days prior to the show.
3. There will be Six breeding group class shows: Fullblood Black, Fullblood Red, Fullblood Red Black, Purebred Wagyu and Percentage Female Wagyu and a Jackpot Prospect Steer Class. Breeding group classes will not compete with each other. There will be 3 divisions of Jr. Showmanship. Junior (ages 8-12) Intermediate (13-15) Senior (16- 21)
4. Cattle must be entered under the recorded ownership at the time of the show entry deadline. Jointly owned animals must be entered under the multi- ownership (a] co-owners) in the individual classes.
5. All animals must be properly tattooed and will be inspected at the show. Tattoo must be legible and must match registration papers. Any animal, upon check-in, which does not have a legible permanent identification mark (ear tattoo marks, freeze-branded marks or hot-branded marks) corresponding to the permanent identification on the registration certificate, is ineligible to show. Once disqualified due to an incorrect or illegible permanent identification mark, animals cannot be retattooed and rechecked at the show.
6. Altering the conformation and/or appearance of an animal for exhibition is prohibited. This includes the covering of white skin, false tail heads (or use of any false hair). The use of graphite, powders, paint, hemp or other similar substances used externally are also prohibited. Animals may not be dyed on the show grounds. Other prohibited products include illegal or unlicensed pharmaceuticals or artificial filling. Any animal found to be in violation will be barred from showing.
7. Winning animals in all divisions may be subject to DNA Parentage Verification (sire and dam only). If the Parentage cannot be verified by the lab, the exhibitor will not be awarded the prize money and the animal will forfeit its winning position.
8. All cattle must meet the health requirements set out by the Dixie National Livestock Show Management. Any deviation will be just cause for immediate disqualification from the show.
9. All bulls above one year of age must show with nose lead. The right to disqualify from the show any animal deemed unmanageable is reserved by the show committee.
10. All females shown in the cow/calf classes must be shown with a calf at side.
11. Calf at side in the cow/calf classes must be her last natural born calf (not an embryo calf born to another recipient).
12. Any person found guilty of misrepresentation of any kind, including age of animal or not abiding by the show rules, will be disqualified and denied the privilege of showing.
13. Juniors may not show bulls. Jr's do not need to own the animal they show however their family must be a registered member of one of the three named Wagyu Associations and must currently own Wagyu cattle.
14. If for any reason an exhibitor or their animal is disqualified, their placing/winnings will go to the exhibitor that placed next behind them.

Points will be awarded for the youth handlers' ability to display an "animal to its greatest advantage." 1. Entries for ALL classes will close on Friday, January 24, 2025. No entry will be accepted after this date. All entries need to be done on online at [www.dixienational.org](http://www.dixienational.org).
2. The show is open to the world.
3. Exhibitors will have access to showgrounds no earlier than 8 a.m., Saturday, February 8. Any exhibitor upon whom this rule would work a hardship may apply to the director of the show for special consideration. All entries must be in place by 6 p.m., Saturday, February 8, 2025.
4. Owners will furnish all feed and bedding for hogs. Facilities will be available to purchase bedding.
5. The show management will not be responsible for losses, injuries or mishap that may befall animals, exhibitors or visitors. The grounds will be policed, and all precautions will be taken to prevent any losses or injuries.
6. All barrows must have been owned by the exhibitor at the time of show. Breeding animals must be accompanied by registration papers registered in the exhibitor's name. BREED DIVISION CLERKS AND SUPERINTENDENTS WILL CHECK EAR NOTCHES AGAINST REGISTRATION PAPERS AND HOLD CERTIFICATES IN OFFICE. Litter registration is acceptable; however, a copy must be provided for each animal entered.
7. Health Requirements (See General Rules). Every entry must have an Individual Health Certificate.
8. Protests and Appeals (See General Rules).
9. Entry fee will be charged at the rate of \$15.00 per head for barrows, gilts and boars. Entry fees must accompany the online entries and will not be refunded. All exhibits must use pens assigned by the show management.
10. Animals will be released upon completion of show, Sunday, February 9, 2025.
11. All premiums will be paid directly to the exhibitors by the Fair Commission.
12. Age and Weight Classification for All Classes Fall Boars - Farrowed on or after July 1, 2024. Fall Gilts - Farrowed on or after July 1, 2024. Barrows: Must weigh between 200-290 lbs.
13. Barrows will be divided into 3 to 6 classes as equal in number as possible. Classes will be determined on the number of entries. Show management will not be responsible for any animals.
14. An exhibitor is not required to show a barrow in order to be eligible to show in the breeding classes.
15. Exhibitors will be allowed one trial weight on barrows.
16. An exhibitor may enter and place only two (2) boar and two (2) gilt entries per breed. Barrow entries will be limited to 6 per family, farm or individual. Only animals that are eligible to be shown may be penned.
17. There will be no clipping allowed in barns and no oil or powder used on breeding animals or barrows.

20. No duplicate awards will be given.
21. Contestants or any coach found in violation of these rules will be barred from future competition and their team disqualified from any and all awards. The decisions of the Superintendent on all matters concerning the contest will be final.
